In pursuance of Hockey Uttarakhand's Letter UHC/EC/Y-22-08 Dt. 01/08/2022 regarding the appointment of Returning officer for election of the Executive Body of Hockey Uttarakhand for the year 2022-2026, I give herein below (1) The particulars of the executives to be elected. (2) The Manner of Election and (3) The Election schedule, for information and benefit of the members of Fencing Association of India who are eligible to participate in the elections.

1. Particulars of the posts in the executive committee to be elected for the remaining period of the term of 4 years i.e. 2022-26.

3. Manner of election:

- The Elections will be held as per the provisions of the Memorandum of Association of Hockey Uttarakhand and the applicable Set of Rules and Regulations adopted by Hockey Uttarakhand and in lines of the Registration of Societies Act 1860.
- Any of the eligible candidate who happens to be an employee of the Central/State government or any of their undertaking/autonomous body, the NOC from the employer has to be mandatorily filed alongwith the nomination form failing which the same is liable to be rejected.
- The election, if required to be held, the same shall be by way of secret ballot. No proxy vote shall be allowed.

- The persons whose names appear in the electoral college should carry a photo identity card of himself, issued by the government such as Aadhar card, voter card, passport, PAN Card etc to enable them to cast their vote.
- Duly filled-in Nomination forms in Form No:2 to be physically delivered in person to the Returning Officer, as detailed under the following Schedule.
- Each candidate shall be entitled to be nominated by not more than 2 nomination papers.
- No person shall be eligible to nominate more than one candidate for the same post, either as Proposer or Secunder.

4. **Grievances:**

Any grievance relating to the election shall be addressed to the Returning Officer.
